- A. A motion was made by Jared Schmidt and seconded by Brad Newman to approve the Mechanical Engineering proposal from SSC Engineering to begin initial planning for the designing of air conditioning for the gymnasium at a cost of \$18,088. 4 Aye, 0 Nay.
- B. An assessment of the regulators was completed by Automatic Fire Control Systems Inc. to correct the issues we are experiencing with classrooms being left without heat due to the regulators not being installed properly during the gas line repair project this summer. The following repairs are needed to correct the issues and ensure our system is functioning consistently and properly: replace all 38 regulators and install all weather caps, reinstall new regulator to code of 18" from roof deck, dirt legs be reinstalled bull headed as opposed to on the run, and gas lines supports need to be placed within 5ft of each unit. The board is requesting that Juergen's Heating and Cooling assist to remedy the situation.
- C. Budget Update- The revenues include the state transmittal for the month. We will see a \$0.25 increase in meal reimbursement due to the USDA decision to offset additional food cost. Expenditures include the first semester HS tuition.
- D. The Grow Your Own Grant is for \$10,000 and will be used to increase certifications for current certified staff in high need areas and to cover the expenses for tuition, testing, and certification. The Teacher Retention Grants is for

\$9,000 and will be used to increase stipends for mentors, for participation in events, and for testing and study materials.
